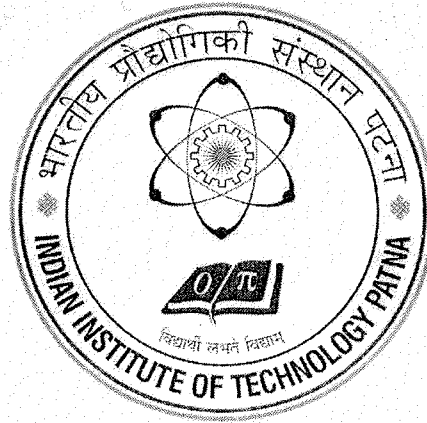

Average Annual Turnover for last three financial years i.e. 2019- 20, 2020-21 and 2021-22 should not be less than 50 % of the estimated cost & Should not have incurred any loss in more than two years during the immediate last five consecutive financial years, ending 31.03.2022.
